

What are cookies?

Cookies are small text files placed on your device when you visit our website. These files help us:

- Remember your preferences.
- Maintain secure sessions.
- Understand how visitors use our website, based on anonymized data (unless otherwise specified).

Some cookies are necessary to make the website work, while others help us improve your experience.

What are the types of cookies?

Cookies can be categorized based on their function. At Anadolubank Nederland N.V., we distinguish between the following types:

- **Necessary Cookies:** These cookies are essential for the website to function properly and securely. They enable basic functions like page navigation, session validation, and form protection. Without these cookies, the website cannot operate correctly.
- **Functional Cookies:** These cookies allow the website to remember choices you make, such as language preferences or cookie settings. They enhance your user experience but are not essential to the website's core operation.
- **Analytics Cookies:** These cookies help us understand how visitors use our website. They collect anonymous statistics, such as which pages are most visited. These cookies are only placed with your explicit consent.
- **Advertising or Personalization Cookies:** These cookies are used to track users across websites and show personalized content or advertisements. At Anadolubank Nederland N.V., we do not use advertising or personalization cookies.

Why do we use cookies?

At Anadolubank Nederland N.V., we use cookies to:

- Ensure the technical functionality and security of our website.
- Remember your preferences and settings.
- Collect statistics (with your explicit consent) to improve our digital services.

We do not use cookies for advertising, profiling, or cross-site tracking. We do not attempt to identify you personally, and we do not sell or share data with third parties for marketing.

We rely on your **explicit consent** in line with the General Data Protection Regulation (GDPR) and the ePrivacy Directive.

Do we use any third-party tools?

Yes. We use Google Analytics to see how visitors use our website (for example, which pages are most popular). This information helps us improve the site's design, functionality, and performance.

The data is collected in an anonymized way and cannot be used to identify you personally. We use Google Analytics in a privacy-friendly way, and we never share analytics data with other companies for marketing purposes.

We do not use any third-party tools for advertising, profiling, or tracking you across other websites.

How do we ask for your consent?

When you visit our website for the first time, you'll see a cookie banner. We only place non-essential cookies (like analytics) if you agree.

Our system makes sure that:

- You are not tracked unless you give permission.
- Your choices are remembered so we don't ask again every time.
- You can change your preferences anytime by clicking "Cookie Settings" at the bottom of our website.
